



# SINGLE FAMILY RESIDENTIAL PERMIT

## Steps to Pull Permit

### 1. What to bring

- Smyrna Planning Department must have a copy of filed plat
- One set of building plans
- “Paid” copy of Development Tax – paid at Rutherford County
- Estimated Construction Cost
- Current copy of Tennessee Contractors License (not necessary if already on file)
- Current copy of Workers Comp Certificate (not necessary if already on file)
- If it is a corner lot – know which street the house will face
- If permit will be in homeowner’s name, you must fill out a TCA form stating that you will be restricted from constructing another residence for personal use for a period of two years.

## FEES

### 2. Development Tax

- Paid at Rutherford County in Murfreesboro - #1 South Public Square
- Call the County Codes Department for amount – (615) 898-7734
- Pay before permit & bring “Paid” copy of Development Tax to Smyrna

### 3. Permit Fees

- Permit Fees – Residential
  - Residential Fee - **\$.30 cents** per square foot – (minimum \$30.00)
  - Requires a separate electrical permit – for info call (615) 896-6117

### 4. Utilities Tap Fees

- Gas, Water, Sewer – Call Utilities Department (615) 355-5740 for amount
  - . Fee must be paid before final inspection is started.

### 5. Electrical Permits

- Call (615) 896-6117

### 6. Impact Fees

- Fee must be paid before final inspection is started.
- Must be on a separate check from the permit & tap fees.
- Fee is: Single Family - \$1,701.00; Multi Family - \$1,160.00 per unit; Mobile Home - \$1,197.00
